#### JOB PURPOSE

Ensure that all customer warranty returns are analysed / tested in detail, to confirm the faults, identify liability and determine acceptance ratios. Provide sufficient detailed analysis to enable warranty cost reduction activities across all SMR-UK customers. To identify and co-ordinate improvement activities aimed at warranty cost reduction across all SMR-UK customers and where applicable implement warranty cost recovery from the SMR supply chain.

### RESPONSIBILITIES

- To conduct analysis of all warranty returns, on site at SMR and at Customer Locations as required, confirming faults. Identify liability and determine acceptance ratios
- To ensure that analysis data is reported to customers within agreed time scales in customer specific format as required.
- To communicate fault and liability information to the relevant internal and external suppliers in order to obtain robust interim and permanent corrective actions aimed at warranty prevention and cost reduction.
- To conduct detailed trend analysis of warranty return parts, claims costs & exposure going forward using Weibull analysis
- To identify warranty reduction opportunities from warranty analysis using robust root cause analysis tools (G8D, 6Sigma etc)
- To Project Manage warranty reduction activities working with cross functional teams (Customer, SMR-UK & Supply Chain) whilst also ensuring that a quick/cheap field fix is developed and introduced to mitigate warranty costs
- To generate from warranty analysis internal QOS sheets/trend analysis.
- To identify warranty recovery opportunities within SMR-UK supply chain
- To support SMR Purchasing department with warranty recovery claims
- To ensure lessons learnt from warranty analysis are communicated across all product / customer platforms and captured on new projects within DFMEA/PFMEA/CP
- To report out warranty reduction and recovery status to Customers, Suppliers and SMR Departmental Managers

- Central to budget preparation on future warranty spend
